CONSENT, RELEASE, AND WAIVER OF LIABILITY

HALIFAX COUNTY LIVESTOCK SHOWS

(To be signed by each participant)

I am the parent/guardian of the minor child named below ("the participant") and am fully competent to sign this agreement. I understand that the Participant's request to participate in the Halifax County Livestock Shows has been approved. I understand that the activity involves various physical activities, including, but not limited to, contact with animals, and that there is a risk of injury associated with such activities. I understand the nature of the activity and my child's participation therein: I have explained these things to the Participant and his/her participation is both willing and voluntary. The Participant is in good health, and deemed able to participate in the activity. In addition, the Participant has adequate health insurance necessary to provide for and pay any medical costs that may arise as a result of injury to the Participant.

Rules & Regulations

1. All entry forms must be received by Thursday, August 1, 2019.
2. This show is being held as part of the Eastern Carolina Showmanship Circuit and will follow all rules in accordance with the circuit.
3. Decisions of the Judge are final.
4. All animals used in competition must be entered in the name of the exhibitor. Animals used in Showmanship Competition must be entered in the name of the Showmanship Exhibitor.
5. Exhibitors are limited to 2 entries each.
6. The show committee may ask any person acting in an unsportsmanlike manner to leave the show.
7. Any exhibitor, parent, or other party involved caught cheating will be disqualified and banned from future shows.
8. Any questions not covered in these regulations will be ruled upon by the show committee.
9. The show committee reserves the right to refuse any animal to show due to health or age reasons.

Meat Goats:

1. All goats must be does or wethers. No bucks will be allowed to show.
2. Goats must have all of their baby teeth on the day of the show.
3. All goats must meet NC health requirements.
4. Goats must be dry at time of weigh-in.

Market Lambs:

1. All lambs must be ewes or wethers. No rams will be allowed to show.
2. All lambs must meet NC health requirements.
3. Lambs must be dry at time of weigh-in.
4. Lambs must be under one year of age (first set of permanent teeth not present) to be eligible to show.

Heifers:

1. All heifers must meet NC health requirements.
2. Heifers must be halter broken. All unruly animals will be asked to leave the ring.
3. Exhibitors need not own the animals, however, NC State Fair rules apply regarding training of heifers.

Directions to the show from Rocky Mount or anywhere south of Rocky Mount:

Via Interstate 95 North:

Take I-95 North to Exit 168. Take a right at the top of the exit ramp. Follow Hwy 903 toward Halifax for about 3 miles. You will see a sign for Halifax County Horse and Livestock Arena on the left (at the corner of Dog Pound Road). Turn left onto Dog Pound Road and take the gravel driveway immediately on the right.

Via Highway 301 North:

Follow 301 North until you get to the town of Halifax. Turn left onto NC-125 N /NC-903 N (at stop light-you will cross railroad tracks). Continue on Hwy 903 approximately 2 miles. Dog Pound Road will be on the right directly after you pass the Rural Life Center.

Directions from Virginia or anywhere North of Halifax County:

Via Interstate 95 South:

Take I-95 South to Exit 168. Take a left at the top of the ramp. Follow Hwy 903 toward Halifax for about 3 miles. You will see a sign for Halifax County Horse and Livestock Arena on the left (at the corner of Dog Pound Road). Turn left onto Dog Pound Road and take the gravel driveway immediately on the right.
